



REGULATIONS

For use of the infrastructure of Nuclea Swimming Section

1) Permitted persons

Entrance to the beach is reserved for those members of the Swimming Section who are in possession of a valid Nuclea membership card.

Members of the Diving Section may also use the beach infrastructure in accordance with conditions stated in the rules of the Diving Section, the laws in force and under supervision of a responsible person for surface safety.

2) Prohibited access

Access is prohibited in absence of a certified lifeguard.
This will be indicated by the presence of a red flag.

3) Beach Opening hours

In July and August: from 10.00hrs until 20.00hrs with surveillance of the beach certified lifeguards.

During the weekends of May, June and September: on decision of the responsible director.

4) Sanctions

Any non-compliance of the regulations will result in the immediate expulsion from the beach.

The Nuclea membership card and the visitors' card will be withheld. The sanctions mentioned in articles n° 6 and 7 are applicable.

5) Access control

Access control can be executed by the directors of Koninklijke Nuclea vzw, the guards of SCK•CEN or persons appointed by the Board of Directors of Nuclea.

6) Abuse of membership cards

Transference and copying of membership cards is prohibited. Abuse of the membership card will result in the card being withheld for a period determined by the directors. The perpetrators should leave the beach immediately.

7) Irregularities

Other irregularities can lead to a warning or retention of the membership card by the persons mentioned in article n° 5, until an appropriate sanction is determined by the directors.

8) Temporary membership cards

For registrations during the holiday period of the Nuclea secretariat, a fixed amount of €60 will be charged for a temporary membership card.

This temporary membership card is valid for a maximum period 1 month after issue, and can be exchanged at the Nuclea secretariat for a valid Nuclea membership card.

9) Visitors' cards

A visitors' card for 5 or 10 sessions can be purchased by the Swimming Section members from the age of 16. The visitors' card is registered on the name of the Nuclea member who is responsible for the visitor on the beach. For every visitor (older than 12 years) 1 session will be charged.

The price for a 5 session card has been set at €25.

The price for a 10 session card is €50.

10) Swimming area

Swimming is only allowed within the swimming area. This area is marked with orange buoys.

11) Children < 10 years

Children under the age of 10 should always be accompanied by an adult.

12) Prohibited for pets

Pets are not allowed on the beach with the exception of guide dogs).

13) Prohibited for motorised vessels

Motorised vessels, canoes, kayaks and surf boards are not permitted.

14) Cigarettes

Please extinguish cigarettes in the disposable ashtrays obtainable from the lifeguards free of charge.

15) Sorting waste

Containers are foreseen for cans, fruit and vegetable waste, other waste, paper, and empty batteries. All waste should be deposited in the appropriate container.

16) Lighting fire

It is strictly forbidden to light a fire.
